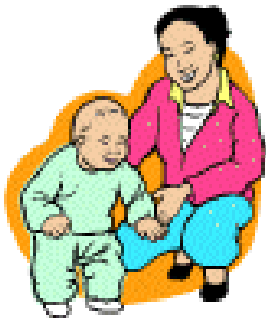

Dear Parents,

Welcome! Your child will be participating in our **Mommy & Me** or **Toddler Fun Club** program. These programs include arts & crafts projects, music & movement, stories, snacks and free play. We suggest that comfortable, casual play clothes be worn to class. Your child will have lots of fun!

Our **Mommy & Me class** (for children 12-24 months old) is designed with the young child in mind. A parent or caregiver will participate with their child in simple arts and crafts projects, singing, story time, snack, and playtime in a warm and nurturing environment. Make new friends, too!

The **Toddler Fun Club** is a special place for your toddler who is between 24-30 months old. This class represents a mini-version of our nursery school program. For many toddlers, it will be their first time "away" from Mommy or caregiver. Crafts, circle time, music and movement, holiday celebrations, snack, and both indoor and outdoor play will be incorporated. Join our club and have lots of learning fun!

Most classes will take place in Classroom 6 in the school wing of our nursery school. Please park in the parking lot and enter from the school wing door. Once enrolled in our program, each family will be given a security code for easy access into our school.

For our Mommy & Me program, state law requires that the parent or another designated adult must accompany and remain with the child for the entire session. No siblings or other family members or friends are permitted to attend class with the enrolled child and designated adult. The procedure is one adult per child attending each class, with the exception of twins.

For our Toddler Fun Club program, state law requires that the parent or another designated adult must remain in the building during class hours (although not in the child's classroom) until your child is 2-1/2 years old.

Our nursery school observes the rules of Kashruth (kosher) within the building of Congregation B'nai Tikvah. All food served in school is either dairy or vegetarian (no meat or shellfish allowed). Smoking is not permitted in the school building or surrounding grounds.

Please note that during inclement weather, if North Brunswick schools are closed, we are closed for the day. Check radio station WCTC-1450 AM, early in the morning for an announcement. A member of our staff will also contact you in the event of a school closing.

We look forward to your participation in our programs!
